#### Dear Members and Friends,





#### **Membership**

The recent concerns regarding the global economy proved to be no hindrance to the growth of the HKVCA, which saw its membership continue to flourish. Indeed, the Association now has a large and diverse group of close to 450 local and international firms as members. Our members consist of a wide range of private equity and venture capital practitioners and, according to the latest industry data, include the top 9 out of 10 largest private equity firms in the world by capital raised over the last five years. With the largest membership base of all comparable industry associations in Asia, the HKVCA is a powerful representative of, and advocate for, the private capital markets in Hong Kong, Greater China and the Asia-Pacific region.

We at the HKVCA recognize that it is our membership that lies at the very heart of this organization. As such, it is my intention, and the collective objective of the Board of Directors, that we continue to expand the membership base across all sectors of the PE, VC and private capital professions and that the HKVCA continues to provide a robust ecosystem in which its member firms can operate and succeed.



#### 会籍

事实证明, 近期对全球经济状况的担忧并没有阻碍香港创业及私募投资协会的成长。本协会的会籍继续呈强势增长。事实上, 本协会现已拥有一个基数庞大且愈发多元化的会员库, 涵盖近450家本土和国际公司, 其中包括各类型的私募和创业投资从业者。根据最新的行业数据, 以过去五年募集的资产总额计算, 全球前十大私募投资公司中有入间皆已成为本协会会员。本协会在亚洲所有同行业协会中拥有最多的会员数量, 是香港、大中华区和亚太地区私募资本市场的有力代表人和倡导者。

我们认识到,构成协会的核心力量是我们的会员。因此,我和董事局全体成员的集体目标是:继续在横跨私募、创业及私人资本界的各领域内扩大会员数目,并持续提供强健的行业生态系统,令我们的会员企业能够顺利运作并取得成功。

#### 活动

我们为会员提供的诸多福利中包含了一个丰富的活动日程。其中部分为年度活动。在2018至2019年间,我们举办了规模不等的活动50余场。我不仅想分享那些吸引了大量与会者参与、拥有较高知名度的论坛和峰会,还想提一提那些规模较小,但同样经过缜密编排,为会员的学习和发展量身定制的活动。

#### • 亚洲私募投资论坛

2019年是亚洲札募投资论坛 (APEF) 举办的第九个年头。该论坛现已成为行业社区中另一个不可或缺的人际和资讯交流平台,并于2019年1月16日将超过750宫经验丰富的从业者汇聚在香港会展中心。代表了包括私募地产和私人债务在内的亚洲各地区各阶段投资的与合者畅享本次机会,与业界同行讨论诸多关键问题,如基金募集、投资者关系、创业投资、私募股权地产、共同投资、资本流动解决方案、投资后价值创造和监管事宜等。

#### **Events**

One of the many benefits provided by the Association to our members is a full program of events, some of which are organized on an annual basis. Of the more than 50 events held in the 2018-19 year, I would like to highlight not only those higher profile forums and summits that draw the largest numbers, but also some of our smaller, but certainly equally well thought-out programs, that are specially tailored to our members' learning and development.

#### Asia Private Equity Forum

2019 marked the ninth consecutive year of the Asia Private Equity Forum (APEF). This indispensable networking and intelligence exchange platform for the alternatives community brought together over 750 experienced practitioners on January 16, 2019 at the Hong Kong Convention and Exhibition Center. Representing investments across all stages and geographies in Asia, including private equity real estate and private debt, attendees relished the opportunity to discuss with industry peers key issues such as fundraising, investor relations, venture capital investing, private equity real estate, coinvestments, liquidity solutions, post-investment value creation and regulatory matters.

#### • China Private Equity Summit

The China Private Equity Summit (CPES) enjoyed its 18th consecutive iteration on May 30, 2019. A leading regional gathering focused on the dynamic and increasingly vital role that the private equity industry plays within China, the latest summit brought together over 700 venture capital and private equity practitioners, leading corporations, and other industry professionals and participants from across the globe. With M&A activity and control deal volumes at record highs, this year's theme was the strength of China's PE and VC industry. Leading industry experts addressed topics such as the impact of China's structural reforms, new policies on regulating overseas investment and what opportunities and challenges lay ahead for cross-border deals. There was also discussion about China's domestic capital market and other sectors, including technology and innovation.

#### • 中国私募投资高峰会

中国私募投资高峰会在2019年5月30日迎来了其第18次会议。作为一场聚焦于中国私募动态及其愈发重要的作用的区域性聚会,最新的峰会汇集了来自全球超过700名创业和私募投资业者、领先企业、以及其他行业的专业人士和从业者。随着并购活动和控股交易量创下历史新高,今年的主题围绕着中国私募和创业投资行业的实力展开。领先的行业专家讨论了中国结构性改革的影响、监管海外投资的新政策、以及跨境交易面临的机遇和挑战等主题。其他讨论主题还包括中国的国内资本市场和包括技术与创新在内的其他部门等。

#### • 亚洲创业投资论坛

我们为协会的年度创业投资盛典, 香港创业投资论坛, 赋予了一个新的名字: 亚洲创业投资论坛(AVCF), 力求反映出本协会日益增强的区域性和全球性的展望和参与度。本次论坛于2019年7月8日, 由本协会与香港数码港、香港交易及结算所、以及香港科技园在香港金融大会堂共同举办, 接待了近400名与会者, 其中包括来自世界各地的投资者和企业家。

#### • 午餐会和研讨会

在过去的一年中,我们组织了广泛的午餐会和研讨会,探讨与我们会员和行业息息相关的各种主题问题。经验丰富的资深演讲嘉宾就美国外国投资委员会(CFIUS)、中国所得税改革、网络安全、以及环境、社会和治理(ESG)等主题进行讨论,为与会者提供及时有效的见解和解决方案。此类活动场场爆满,由此可见,我们的会员非常看重这些能让其跟上当前趋势、与同事和同行业者建立联系的机会。

我想着重强调一下本协会今年举办的两场非技术性研讨会,第一场专注于私募投资行业的女性,第二场着眼于压力管理。随着越来越多的女性进入亚洲私募和创业投资行业,我们开始意识到解决性别平等的必要性,并注意到行业中的女性在事业发展上遇到的障碍。本场研讨会参与人数众多,其中超过八成是女性,很多人在公司更是跻身中高层。

#### Asia Venture Capital Forum

We changed the name of our annual venture event, the Hong Kong Venture Capital Forum, to the Asia Venture Capital Forum (AVCF) to reflect the Association's increasingly regional – and global – outlook and level of engagement. Held on July 8, 2019 at the HKEX Connect Hall, the event was co-hosted by Hong Kong Cyberport, Hong Kong Exchanges and Clearing and Hong Kong Science and Technology Parks. AVCF 2019 hosted close to 400 attendees, including investors and entrepreneurs from around the world.

#### Luncheon Talks and Seminars

During the year, an extensive range of luncheon talks and seminars were organized to address different topical issues of relevance to our members and the industry. Animated discussion on subjects as varied as CFIUS, Chinese income tax reform, cyber security and ESG were presented by experienced senior speakers, providing timely and useful insights and solutions to attendees. These events were all oversubscribed, leaving little doubt that our members value the opportunity to be up to date with current trends and to network with colleagues and industry peers.

I would like to highlight in particular two of the non-technical seminars the HKVCA hosted this year, one focused on women in private equity, and the second on stress management. As more and more women are entering Asia's PE and VC industry, we have come to recognize the need to address gender equality as well as the barriers to women developing their careers in the industry. The seminar was well attended: more than 80% of the audience were women, many of them senior members of their firms.

Stress is an affliction that is often spoken about by professionals in the city, and practitioners in the PE and VC industry are no exception when it comes to suffering the physical and mental damage that stress can cause. In light of this, the Association organized a luncheon talk dealing with stress management. Conducted by clinician-psychiatrist Professor Lee Sing of the Chinese University of Hong Kong, the seminar examined the sources of stress and how to cope with it. More than 30 people attended the event, with most agreeing that Professor Lee's analysis and advice was extremely beneficial.

压力是生活在城市的专业人士经常谈论的苦楚,私募和创业投资行业的从业者在遭受因压力带来的身心伤害时也不例外。鉴于此,本协会组织了一场关于压力管理的午餐会。该研讨会由香港中文大学的临床医生及精神科学家李诚教授主持,研究了压力的来源以及应对压力的方法。30多人参与了此次活动,大多数人表示李教授的分析和建议令自己受益匪浅。

本协会不仅可组织着眼于行业及职业支持的资讯类和教育类活动,还可举办更具普遍性、提供生活视角的活动,我对此深感自豪。听到会员们也认为这些活动具有特殊价值,也令我们再次得到了肯定。本协会将继续更踊跃举办此类活动,为会员提供行业学习和其他福利。

#### • 私募投资课程

香港创业及私募投资协会的使命之一, 便是 促进行业道德、国际最佳实践以及标准。我 们严谨承担起责任, 培养和教育那些在私募 和创业投资行业寻求进一步职业发展的人 才。 完成这一使命的核心项目便是我们全面 而优质的教育培训课程: 香港创业及私募投 资协会私募投资基础课程。 今年的八个模块 课程由经验丰富的行业顶级业者牵头。他们 与课程参与者分享了深入的技术和实践知 识。该套基础课程已进入第九个年头, 其已 成为行业初学者和有志丰富知识储备的人 才不可错过的培训项目。对于那些希望为新 进员工培养技术和实践专业知识的私募或 创业投资公司而言,该套课程也已成为一个 备受他们推崇的优质平台。事实上, 我们去 年吸引了90多位参与者加入课程。

除了基础课程之外,我们在2018年还为中高级专业人士推出了香港创业及私募投资协会私募投资高阶课程。该课程的前两个模块:谈判和百日计划,皆已于去年上半年成功发布。第三个模块:董事会,也于2019年4月16日举行。我们收到了来自与会者的大量积极反馈,并已计划在未来将其打造为每两年举办一次的固定活动。

I am proud that your Association can provide not only the kind of informative and educational events that are industry-focused and career-supporting, but also events that are more general and offer life perspective. It is reaffirming to hear that members find them valuable. The HKVCA will continue to host more of these types of events, providing both industry learning and other benefits to our membership.

#### • Private Equity Courses

One of the missions of the HKVCA is to promote industry ethics, international best practices and standards. We take seriously our responsibility to nurture and educate individuals seeking to further develop their careers in the PE and VC industry. The core program of this mission is the HKVCA Private Equity Fundamentals Course, a comprehensive and quality education and training course. This year's eight module curriculum was led by highly experienced toptier industry practitioners who shared their in-depth technical and practical knowledge with course attendees. In its ninth year, the Fundamentals Course has become a must-attend program for industry beginners and individuals who wish to increase their knowledge. It is also a well-regarded platform for private equity and venture capital firms who would like to develop their juniors' technical and practical expertise. Indeed, last year we had more than 90 participants register for the program.

#### • 社交活动

诚然,我们的会员一直都在"努力工作",但他们也热衷于"尽情娱乐"。因此,本协会举办了数个备受欢迎的社交活动,包括年度晚宴和高尔夫球日、以及鸡尾酒会和品酒会等。我们的每一场社交活动都深受欢迎,每次含额都供不应求。

篇幅所限,我只能简要提及过去一年本协会举办的诸多活动中很小的一部分。未来,我们将继续努力为会员提供更加广泛的机会,令大家不仅可以与新老朋友会面交流,还可以与同行和同事分享行业经验和资讯。



Apart from the Fundamentals Course, in 2018 we also launched the HKVCA Private Equity Advanced Course for mid-to senior-level professionals. Two modules, negotiation and the 100-day plan, were successfully delivered in the first half of the last year with the third, directorship, held on April 16, 2019. We received a great deal of positive feedback from attendees and intend to run it on a biannual basis in the future.

#### Social Events

Of course, while our members "work hard", they also like to "play hard" and so your Association hosted several very popular social events including our annual Gala Dinner and Golf Day, as well as cocktails and wine tasting occasions. All proved to be well received with each of our social events being oversubscribed.

Space has limited me to mentioning only a handful of the many events that the HKVCA held this past year. Going forward, the Association will continue to work hard to provide our members with extensive opportunities not only for networking and meeting friends old and new, but also for sharing industry experience and information with peers and colleagues.

#### **New Committees**

Whenever an issue becomes a concern for our members and requires us to proactively address it, the Association will act to create a new committee to determine the HKVCA's view and advocate on our members' behalf. In the 2018-19 year, two new committees were formed:

#### Women Committee

The HKVCA wants to play an active role in addressing gender equality in the workplace, and as such the Board of Directors formed a new committee to represent the interests of women in the PE and VC industry. The Committee hopes to organize a series of events and programs and keep track of the industry's performance when it comes to gender equality. The increasing focus globally on gender balance in the workplace will have an impact on financial services and it is important that the Association is aware of and can follow these developments in order to encourage diversification and gender equality among its member firms in the private capital industry. Ultimately, the committee intends to liaise with government and seek opportunities to provide input to future policy formulation concerning gender balance within the financial industry.

#### 新委员会

每当会员有了新关注的问题并期待协会积极解决时,我们便会采取行动,建立新的委员会以确定本协会的观点并代表我们的会员发起倡议。在2018之2019年间,我们设立了两个新的委员会:

#### • 女性委员会

香港创业及私募投资协会希望在处理职场性别平等问题上发挥积极作用。因此,董事局成立了这一全新的委员会以代表私募及创业投资行业中女性的权益。在涉及性别平等方面,委员会希望组织一系列活动和项目,同时跟进行业表现。全球对于职场性别平衡越来越关注,这也必将对金融服务业产生影响。协会必须了解到并目能够遵循这些发展,以鼓励身处私募投资行业中的会员企业实现多样化和性别平等。最终,委员会计划与政府联络,寻求机会为未来有关行业内性别平衡的政策制定提供意见。

#### • 私募债权委员会

香港创业及私募投资协会代表长期非流动性另类投资策略,其中私人债务是有限合伙人非流动资产组合的重要组成部分。亚洲的私募债权参与者数目正在增加,一些会员正在扩大其投资范围以包括债权策略。因此,本协会成立了私募债权变员会,通过围绕私募债权为主题的研讨会和定期对话来解决特定债务的技术问题,以满足该部分会员的利益。

#### 政府倡导

一个行业协会必须积极代表其会员企业发声,并向政府表达相应关切。我们通过与多个政府及其他部门的持续游说,旨在参与塑造本行业监管和征税的方式。在会员们的专业知识和建议的支持下,本协会在过去的一年中继续努力,增强与不同政策制定者间的关系,并与他们建立持续不断的沟通渠道。我们重点将时间和资源用于下述五个议题:



#### Private Credit Committee

The HKVCA represents long-term illiquid alternative investment strategies, of which private debt is an important component of an LP's illiquid asset portfolio. The number of private credit players in Asia is growing, and some members are expanding their investment spectrum to include credit strategy. As a result, the Association formed the Private Credit Committee to cater to the interests of this group through credit focused seminars and regular dialogue to address debt-specific technical issues.

#### **Government Advocacy**

An industry association such as ours must be active in speaking out on behalf of its member firms and expressing relevant concerns to the government. Through our continual lobbying of several government and other entities, we aim to participate in shaping the ways in which our industry is regulated and taxed. Armed with expertise and input from members, the Association continued its efforts during the year to strengthen our relationships with various policy makers and to develop ongoing channels of communication with them. We devoted our time and resources to five issues in particular:

#### • Listed Private Equity

In early 2018, the HKVCA established a working group on listed private equity and the group prepared a dual listing proposition to highlight the demand for private equity fund listing in Asia. The working group arranged meetings with different agencies, in particular the main stakeholder for this topic, Hong Kong Exchanges and Clearing (HKEX). The working group also organized a fact-finding trip to London in September 2018. We were grateful to have opportunities to discuss the LPE initiative with the London Stock Exchange, fellow associations, including the Listed Private Capital, British Private Equity and Venture Capital Association and the Association of Investment Companies, and a number of leading listed PE professionals and service providers in the UK. Hong Kong delegates included representatives from the Hong Kong Monetary Authority (HKMA) and InvestHK. The HKVCA has received some indications of interest in conducting secondary listings in Hong Kong and the working group will continue to discuss this with HKEX and liaise with market participants in the coming year.


#### • 上市私募股权

2018年初, 香港创业及私募投资协会成立 了上市私募股权工作小组,制定了两地上提 案, 以强调私募股权基金于亚洲上市的需 求。工作小组与不同机构举行会议, 特别是 香港交易及结算所(港交所)这一与该议题 最主要的利益相关者。小组还于2018年9月 组织了一次伦敦实况探寻之旅。 我们很高兴 有机会与伦敦证券交易所, 和包括上市私募 基金协会、英国私募和创业投资协会、投资 公司协会在内的同行协会、以及英国部分领 先的上市私募股权专业人人士和服务机构探 讨上市私募股权的倡议。香港代表团成员包 括香港金融管理局 (金管局) 及投资推广署 的代表。本协会已获取一些有意在香港进行 二次上市的迹象。工作小组明年会继续与香 港交易所商讨, 并与市场参与者保持联络。

#### • 关于将利得税豁免扩展至基金的磋商

香港创业及私募投资协会受财经事务及库务局邀请参与磋商,修订税务框架中有关"与本地经济分隔"的现行规则。我们提交了两轮磋商的反馈意见并与财经事务及库务局安排会议。令人高兴的是,我们的大部分建议都被采纳并录入修订法案中。利得税豁免规则也最终扩展至离岸私募股权基金。本协会将继续代表业界沟通,确保该法规得以有效施行。

#### Consultation to Extend the Profit Tax Exemption to Funds

The HKVCA was invited by the Financial Services and the Treasury Bureau (FSTB) to participate in the consultation to amend the existing rules around ring-fencing in the taxation framework. We submitted feedback to two rounds of consultation and scheduled meetings with the FSTB. To our delight, most of our suggestions were adopted and included in the amendment bill, and the profits tax exemption rule was finally extended to offshore private equity funds. Your Association will continue to lobby on your behalf to ensure that the rule is implemented effectively.

#### • Onshore Limited Partnership Regime

Hong Kong's Limited Partnerships Ordinance has not been updated nor amended since 1912, preventing general partners from establishing private equity funds in Hong Kong. The HKVCA began discussing wider reform to expand private equity activities in Hong Kong in 2010. Prolonged lobbying by us resulted in the government announcing in 2017 that it was considering a new limited partnership rule. In 2018, the HKMA was assigned the task of conducting an industry survey of the limited partnerships regime and the Financial Secretary confirmed that the consultation will begin in 2019. The HKVCA is going to discuss the regime's development with the FSTB and HKMA, and I would like to reassure members that their voices will be heard, and their views delivered to the government.

#### Regulation and Licensing

In late 2018, the HKVCA met with the Securities and Futures Commission (SFC) to discuss licensing. We pointed out that confusion over existing licensing categories and the long waiting period once an application is submitted have caused problems for several wouldbe industry participants. We urged the SFC to prepare a list of FAQs for private equity and venture capital professionals in order to avoid further confusion. We also established a working group early in 2019 to liaise directly with the SFC to prepare these FAQs. We are certain that clear guidance in licensing will provide clarification as to which type of license is appropriate and will benefit the onshore LP regime in future.

#### • Cayman Economic Substance

A large number of Asian PE funds are based in the Cayman Islands. Asian advisors who are Cayman-registered fund managers are required to comply with the recently implemented Economic Substance Law, which requires companies to maintain a level of operational substance that is effectively commensurate with the income generating activities of that company. The HKVCA is discussing the substance law with various governments in the region in order to provide an effective solution to accommodate this group of Asian practitioners ahead of the January 15, 2020 deadline. We will continue to devote resources to resolve this matter and hope we can arrive at the best solution soon for our members and our market peers.

#### · 在岸有限合伙制度

自1912年以来,香港的《有限责任合伙条例》就未曾被更新或修订,阻碍了普通合伙人在香港设立私募股权基金。香港创业及私募投资协会于2010年开始就更广泛的改革进行讨论,以扩大香港的私募股权活动。我们长期以来的游说令政府在2017年宣布考虑新的有限责任合伙法规。2018年,香港金融管理局(金管局)被委任对有限责任合伙制度进行行业调查。财政司司长确认磋商将于2019年开始。本协会将与财经事务及库务局和金管局讨论该制度的发展,我向诸位会员保证,业界的声音会被听到,业界的意见也会被传达给政府。

#### • 监管和发牌

2018年底,香港创业及私募投资协会与证券及期货事务监察委员会(证监会)开会讨论发牌事宜。我们指出,申请一经提交,对现有发牌类别的疑惑和漫长的等待期已经为数位潜在的行业参与者带来了问题。我们促请证监会为私募及创业投资专业人士编制一份常见问题清单,以避免进一步混乱。我们亦于2019年初成立了一个工作小组,直接与证监会联络,准备这些常见问题。我们确信,清晰的发牌指导会澄清哪种牌照对于在岸有限合伙制度是合适并且在未来有利的。

#### **External Relations**

As it has done in previous years, this year the HKVCA supported over 50 events organized by several fellow private equity and venture capital industry associations, as well as firms in the industry.

The Annual Asian Venture Capital Private Equity Council meeting was hosted by the HKVCA in January and saw members discuss investment trends and regulatory updates within their respective home countries. The HKVCA will participate in the Global Venture Capital Congress in 2020 and is looking forward to further collaboration with fellow Council members.

Many other internal and external meetings were held during the year, with members, committees, and other parties (including HKEX, SFC, FSTB, FSDC, HKTDC, IRD and InvestHK) with an interest in the PE and VC industry. We were also delighted to be able to meet international GPs and LPs, including PSP Investment, who we helped advise on its decision to set up an office in Hong Kong.

The HKVCA has maintained strong relationships with the MBA programs offered by the local universities, including the University of Hong Kong, Chinese University of Hong Kong and the Hong Kong University of Science and Technology (HKUST), with whom we partner to deliver the Private Equity Fundamentals Course. In fact, the material for the case study module was developed in cooperation with HKUST, and MBA students have been encouraged to join the course as a way of fostering their enthusiasm for the industry. We also are planning to co-host and support activities with international business schools, such as INSEAD and the London Business School, in the coming years.

#### **Board, Committees and Staff**

I have mentioned only the highlights of the HKVCA's many activities over the course of the past year. I would like to take this opportunity to acknowledge and pass on our sincere appreciation to the multiple firms, partners and committee members who have worked closely with the HKVCA to make our events such a success.




