The last 12 months brought unprecedented challenges to each of us, as individuals and as professionals. Yet, we stood together and persevered. In spite of a city-wide slowdown in early 2022, the HKVCA rolled out a full agenda of events. Learning from the previous two years' experience of hosting virtual and hybrid programs, we adapted swiftly, maintained the quality of each event and delivered the best results for our members.

Events

The impact of the COVID-19 pandemic eased in the fourth quarter of 2021 in Hong Kong, and we were able to seize the opportunity to organize several small-scale in-person networking events. These included two long-awaited Members Breakfast Meetings, the Golf Day and Christmas Cocktails. It was amazing to meet so many members and friends face-to-face. The events were oversubscribed, which reflected participants' strong desire to meet in person rather than virtually.

Of the 42 events the HKVCA organized in the past year, we received more than 6,300 registrations. Our "Big3" annual flagship conferences accounted for one-third of these registrations. The Asia Private Equity Forum (APEF) was held on January 12, 2022, the Asia Venture Capital Forum (AVCF) on March 11, 2022, and the

活动



China Private Equity Summit (CPES) on August 24, 2022. Both APEF and AVCF were held virtually, as the fifth wave of COVID-19 was then spreading across Hong Kong. We did include some in-person components, with the physical attendance of a handful of speakers at APEF. Gratefully, CPES was open to both online and offline attendance and we hosted more than 800 delegates at the Hong Kong Convention and Exhibition Centre and through the virtual event platform. We received overwhelmingly positive feedback from the audience, who considered ours to be Asia's premier industry event.

In addition, close to 30 webinars were held covering a wide variety of subjects, including impact investing, tokenization, and digital assets, as well as regulatory updates. The Diversity & Inclusion Committee organized a webinar on effective communication.

Membership

The HKVCA is committed to our members in the region, and increasingly, around the world. Our membership continues to flourish and, despite the year's challenges, has expanded. Today, the HKVCA has 500 corporate members from all sectors of the private capital industry, making it Asia's largest venture capital and private equity association.

报名参与我们三大年度旗舰论坛的人数占 这一总数的三分之一。其中亚洲私募投资 论坛(APEF)于2022年1月12日举行, 亚洲创业投资论坛(AVCF)于 2022年 3月11日召开,而中国私募投资高峰会 (CPES) 则于 2022 年 8 月 24 日举办。 因为香港第五波新冠疫情的扩散, 亚洲私 募投资论坛(APEF)和亚洲创业投资论 坛(AVCF) 皆为线上举办, 但我们仍在 亚洲私募投资论坛(APEF)中增加了一 些线下元素, 邀请了少量演讲嘉宾亲自莅 临线下会场。幸运的是, 我们的中国私募 投资高峰会 (CPES) 得以于线上和线下 同步举行。我们在线下的香港会议展览中 心和线上的虚拟活动平台共计接待了800 多名与合代表, 收到了观众的一致好评, 峰会更被誉为亚洲首屈一指的行业盛会。 此外, 我们还举办了近30场网络研讨会, 涵盖了包括影响力投资、代币化、数字资 产,以及监管更新在内的广泛主题。 写元 共融委员会还组织了一场探讨有效沟通技 巧的网络研讨会。

会籍

HKVCA 一直致力于服务来自本地区、以 及越来越多遍布世界各地的会员。尽管今 年面临诸多挑战, 我们的会员基础仍保持 蓬勃发展, 会员数量仍在不断扩大。如 9, HKVCA 已拥有 500 家来自私募资本 行业各个领域的企业会员, 已成为亚洲规 模最大的创业和私募投资行业协会。

会员始终是本协会的核心。 作为协会主 席、壮大我们跨地区、跨行业、跨私募资 本全专业领域的会员基础是我的首要任 务,同时也是董事局的共同目标。培育出 一个强大的生态系统, 让我们的会员企业 可以在其中学习、成长并取得成功是我们 的使命。作为您的代表,HKVCA 董事局 和团队成员会始终致力将您的利益置于我 们所有工作中最重要的位置。


Education

Developing industry standards, sharing knowledge and nurturing talent are among the most important issues on the Association's agenda. Our proprietary and long-standing Private Equity Fundamentals Course is the best testament to that, an educational series that is delivered annually by seasoned industry-leading specialists for young entrants to the industry and mid-career professionals who wish to refresh and update their skills. Social distancing limitations meant that the Course was held largely online from August to November 2021, although the first module was hosted in hybrid format for roughly 40 in-person attendees and 70 online. There was less interaction between the instructors and attendees, but the virtual format allowed participants from around the region to join, and hence the registration numbers were more than double the numbers we have seen when it was held in a purely physical format.

教育

制定行业标准、分享知识和培养人才是协 会最重视的议题。 我们持续多年举办的自 有私募投资基础课程就是对此最好的证 明。该课程每年由经验丰富的行业领先专 家为新进入行业的年轻人和那些希望提升 专业技能的处于职业中期的专业人士提供 一系列教育培训。新冠疫情期间的社交距 离限制使得在2021年8月至11月期间 开设的该课程大部分都采用了线上授课的 形式,不过课程的第一个模块得以经线上 线下结合的双轨形式举办,约有40人线 下参与,70人在线参与。尽管线上的授 课形式令讲师和与会者之间的互动减少, 但其为身处其他地区的人提供了参与机 会, 因此今年的课程报名人数是我们过往 纯线下举办该课程时的两倍多。

为继续促进私募资本发展,HKVCA 计划于 2023年初成立"HKVCA 私募基金培訓研究所"。这项新的教育和研究计划旨在开发与私募资本资产类别相关的结构更完





To continue promoting private capital, the HKVCA plans to establish the HKVCA Institute for Private Capital in early 2023. This new education and research initiative is intended to develop and provide more well-structured training, relevant to private capital asset classes and to professionals in a wider range of related industries and functions, such as those in private banking, wealth and asset management.

Industry Standard

The HKVCA launched its third ESG Award of Excellence in 2021 aimed at recognizing significant environmental, social and governance (ESG) related initiatives and achievements in Asian private equity and venture capital-backed companies. Of the 26 ESG case studies received from a broad range of private equity and venture capital firms across Asia, the HKVCA honored three winners at a special awards ceremony during APEF 2022.

行业标准

HKVCA 于 2021 年发起了第三届 ESG 卓 越奖, 旨在表彰那些得到亚洲私募和创 业投资支持的公司在环境、社会和管治 政策(ESG)领域方面的重大举措和成 就。从全亚洲范围内广大私募和创业投 资公司处征集到的总共 26 个 ESG 案例 研究中, HKVCA 评选出三位优胜者, 并 在2022年度亚洲私募投资论坛(APEF) 期间举办的特别颁奖典礼上为其颁奖。

政策倡导

HKVCA 始终奉献于我们的香港根基。我 们广泛接触并参与政府事务。同时, 我 们作为行业协会, 经常被呼吁为政策提 供咨询, 并为政策制定做出贡献。我们 对此深感骄傲。

HKVCA 技术委员会在相关工作中负责牵 头。其过去一年的重点关注之一, 便是 有关附带权益税务宽免的《税务条例释 义及执行指引(DIPN)》。技术委员会不 止一次与香港财经事务及库务局、香港

Policy Advocacy

The HKVCA is committed to our Hong Kong roots. We are proud of our extensive engagement with the government and the fact that we as an association are often called upon to provide policy consultations and contribute to policy formulation.

Leading at the front is the HKVCA's Technical Committee. One of its focuses this past year was the Departmental Interpretation and Practice Note (DIPN) on the concession tax rate for carried interest. The Technical Committee met more than once with the Financial Services and the Treasury Bureau, Financial Services Development Council, Hong Kong Monetary Authority and Inland Revenue Department to discuss the implementation. Two issues - "routing via HK" and the "zero hurdle rate" - were identified and the committee is continuing to discuss these with relevant government agencies.

With regards to the family office tax exemption regime, the HKVCA is supportive of the proposal. However, many single-family offices (SFOs) are not willing to move their central management and control to Hong Kong, which is key to attracting overseas SFOs. The

在家族办公室税务豁免制度方面,HKVCA 对该提议表示支持。然而,许多单一家族 办公室(SFO)不愿将其中央管理和控制 任至香港,这是吸引海外单一家族办公室 (SFO)的关键。技术委员会与协会中的 家族办公室委员会联手向政府提交了一份 反馈。

除税务问题之外,HKVCA 也注意到了 CPT (持续专业培训)要求的变化带来的影响。技术委员会开设了数场内容丰富的培训课程,帮助会员更好地了解那些满足合规、道德和监管课题的额外 CPT 所必需的要求的更新。



Technical Committee submitted a response to the government in concert with the Association's Family Office Committee.

Beyond taxation issues, the HKVCA also recognized the impact of changes to the CPT requirements. The Technical Committee organized several informative training sessions for members to better understand the updated requirements necessary to satisfy the additional CPT for compliance, ethics and regulatory subjects.

Last but not least, the Association was also involved in several consultations during the past year. Chief among these were the Chief Executive's Policy Address and the Financial Secretary's Budget Speech. Our latest discussions with government officials focused on loosening the COVID-19 restrictions for business travelers, especially on quarantine requirements, and also the flight suspension mechanism. We hope our feedback will assist the government in designing policies that benefit our members and the private investment market with an immediate impact.

Appreciations

I have mentioned only a few highlights of the HKVCA's many activities over the course of the past year. I must take this opportunity to acknowledge the multiple members and partners who have worked closely with HKVCA staff to make our events a success.

Together, I know that we can forge ahead and continue to develop a strong and vibrant HKVCA that is the leading regional professional association for our industry.

The year 2022 marked the 35th anniversary of the HKVCA. It was a salient moment to commit to our continued striving for excellence and, with an eye to the future, embrace the successful years to come.

ASIA 2022 Private Equity Forum 12 January, 2022 (Wednesday)

The Hong Kong Venture Capital and Private Equity Association's (HKVCA) 12th Asia Private Equity Forum (APEF) was held virtually on January 12, 2022. As the region's premier private equity event, the annual Forum featured an exceptional line-up of expert speakers and panelists. This year, more than 60 general partners, limited partners and industry professionals came together, addressing the latest trends driving the growing and increasingly robust private markets in Asia. The **21**st HKVCA China Private Equity Summit

The China Private Equity Summit, one of the HKVCA's major flagship events, was held for the 21st consecutive year on August 24, 2022. Long recognized as the China PE industry's leading practitioners' conference, this year's sessions were held in a hybrid format and were attended by participants both in-person and online virtually. The result was significantly greater engagement from across the region and around the world, with more than 800 venture capital and private equity practitioners, leading corporates, and other industry professionals attending the event.

Among the distinguished guests were the Hon. Christopher Hui, Secretary for Financial Services and the Treasury of the Hong Kong SAR government; Nicolas Aguzin, the CEO of HKEX; and Yi He, Co-Founder & CMO of Binance.

Held at the Hong Kong Convention and Exhibition Centre, the theme of the discussion this year highlighted the many opportunities that continue to be present in the market in China, including in such sectors as fintech, consumer products and services, deeptech and climatetech. Current sentiment among LPs and family offices was also a focus, as were the challenge of SPACs listings; the latest developments in the PE secondaries market; RMB funds and government guidance funds; and the advantages to be found in Hong Kong spurred by a number of new private equity-related policies.

Similarly, the move by many corporates in China to embrace stricter governmental oversight and acknowledge that the "reckless" tech era is over, means there continues to be a consensus of uncertainty as to how all these factors will impact the Chinese economy, not to mention ongoing global political and economic instability, supply chain disruptions and increasing inflation around the world.

Thank you also to our PRC Committee, co-chaired by Conrad Tsang and Jacob Chiu, and to the other committee members.
