
President Xi stated to the United Nations General Assembly that China is targeting peak carbon dioxide emissions by 2030 and carbon neutrality by the year 2060. The 14th five-year plan also clearly stated the strategic goals that both energy consumption per GDP and CO2 emissions will be reduced by 13.5% and 18% respectively by 2025. Against this backdrop:

- What are the key investment opportunities within the clean tech space in China?
- In 2020, EV accounted for around 6% of China's passenger vehicle sales volume. The government expects clean energy vehicle sales to reach 20% by 2025 and 40-50% in the long run. Do you think this goal is achievable and what will be the drivers and hurdles?
- Do you have different return requirements when investing in the clean tech space?
- ESG is getting more important for investors, is there any impact on clean tech investments?
