HKVCA Successfully Concludes its China Private Equity Summit 2018

Hong Kong, 5 June 2018 – The China Private Equity Summit (CPES) 2018, organized by the Hong Kong Venture Capital and Private Equity Association (HKVCA), successfully concluded today. This one-day event featured more than 70 speakers and panelists and was attended by more than 550 delegates.

Held at the Hong Kong Convention and Exhibition Centre, distinguished guests included **James Henry Lau Jr, JP**, Secretary for Financial Services and the Treasury, Government of the Hong Kong SAR; **Forest Lin**, Managing Partner, Tencent Investment; **Roger Luo**, President, DJI; and **Johan Bygge**, Chairman of Asia Pacific, from EQT Partners.

The theme this year highlighted the strength of China’s PE/VC industry, with M&A activity and control deal volumes at record highs. Leading industry experts addressed such topics as the impact of China’s structural reforms, new policies on regulating overseas investment and what opportunities and challenges lie ahead for cross-border deals. There was also discussion about China’s domestic capital market and other sectors, including technology and innovation.

Conrad Tsang, President of the HKVCA, said: “the China Private Equity Summit remains one of the industry’s most well attended regional gatherings with many distinguished guests and leading experts discussing the latest developments and trends facing private equity practitioners in China”.

“2017 was by any measure one of the most active years for new investments and exits in China’s PE and VC industry”, Tsang continued. “There were many PE and VC backed unicorns accessing both private and public markets to raise funding, and M&A and control deal volumes were at record highs last year. As one of the largest industry associations, we remain committed to engaging with our members, developing ideas and strategies, and seeking new opportunities.”
