HKVCA Mission Statement


The HKVCA's mission is to stimulate a vibrant venture capital and private equity industry in Asia while promoting the role of member firms in value creation, innovation and economic development.



t is my great privilege to deliver this report detailing the outstanding work undertaken by the Hong Kong Venture Capital and Private Equity Association (HKVCA) over the course of the past year.

Membership

The year was a strong and largely positive one for our industry and so too it was for the HKVCA. During the period covered by this report, our membership numbers continued to grow unabated. At the time of writing we have a diverse and accomplished membership of more than 320 professional firms, representing practitioners across the full spectrum of private capital markets. Our member firms hail from Hong Kong, Greater China, the Asia-Pacific region and other parts of the world, including Europe, North America, and frontier markets such as Russia. Indeed the international nature of our membership is itself a reflection of Hong Kong's unique status within China and of the fact that Hong Kong is not simply a regional centre but a global centre for business and finance.

Major Events

As a driving force for growth and professionalism within our industry, and as part of our ongoing commitment to our members, the HKVCA organizes a full and very active calendar of events. These range from high profile conferences and industry-relevant lectures to both informal and formal training programs and social events.

Traditionally our two most high-profile events have been the annual Asia Private Equity Forum and the annual China Private Equity Summit. However, since its initial launch in 2013, the Hong Kong Venture Capital Forum (HKVCF) has proven so successful that it is entirely fair to say that it has become one of our flagship events and now an annual fixture on the calendar for the private equity and venture capital industry. This year's event featured leading regional venture capitalists discussing the evolving venture environment, including the latest developments and trends in financial technology (fintech), medical technology (medtech) and the internet of things (IoT).

This year marked the fifth year we have held the Asia Private Equity Forum (APEF) and the fourteenth year we have held the China Private Equity Summit (CPES). These events have gone from strength to strength and featured many of the industry's best known experts as speakers and panel members, with each attracting more than 500

participants from around the world. Both of these annual conferences, which take an enormous amount of work and preparation on the part of our members and the HKVCA staff, offer vitally important alternatives to events being offered by commercial providers, ensuring that a broad spectrum of expertise and a diversity of discussion is available to the financial services industry.

The HKVCA's Private Equity Fundamentals Course, which we have been running since 2009, is a comprehensive course offered through a series of modules with the goal of providing professionals with a greater understanding of the core principles involved in the private equity and venture capital industry. We have continued to work very closely with our partners, the Hong Kong Exchanges and Clearing Limited (HKEx), and the MBA programs at the University of Hong Kong and the Hong Kong University of Science and Technology. During the period covered by this report, 138 persons attended the course, the highest number since its inception.

Of course our members like to have their fun too, and in that spirit the HKVCA held a number of popular social events over the course of the year. Chief among them was our annual Gala Dinner, held on the evening before



主要活动

香港创业及私募投资协会每年积极组织丰富活动,致力 于推动行业内部发展及专业化拓展,并履行对会员的承 诺。一系列活动不仅包括广受关注的大型会议和行业相 关的课程,更涵盖了正式和非正式的培训项目以及社交 活动等。

以往,我会的两场年度盛典是亚洲私募投资论坛和中国 私募投资高峰会。然而,自2014年首秀之后,香港创业



the APEF on January 20, 2015. Close to 200 guests were able to enjoy a live music performance and delicious food. Our annual Golf Day, held on April 24, 2015, and our series of wine tasting evenings, both proved especially popular and were consistently oversubscribed.

Development of the Profession

The HKVCA continues to recognize the importance of our efforts aimed at promoting professional development and industry awareness. One of our newest initiatives, undertaken by the Research Committee, has been the release of our first and second issues of the HKVCA Journal in December 2014 and June 2015 respectively. We also published a joint special report examining private equity in Hong Kong. Research is a valuable resource, and we have worked to partner with commercial, academic, trade and public sector organizations in new initiatives that benefit the Association in particular and the venture capital and private equity industry in general.


I am also pleased to report that, thanks in no small measure to the outstanding work of our Technical and External and Public Affairs Committees, the Inland Revenue (Amendment) (No. 2) Ordinance 2015, extending the profits tax exemption for offshore funds to private equity funds, was gazetted on 17 July 2015 and came into operation on the same day. Now that the exemption has actually become law, we expect to see a steady increase in the number of fund managers setting-up and expanding their businesses in Hong Kong, enhancing our role as a global financial centre. Anticipating and helping to shape developments in the way governments interact with, regulate and tax our industry is among the HKVCA's most important missions and this will remain an absolute priority as our industry faces increased regulation, both in Hong Kong and around the world.

Board, Committees and Staff

I have mentioned only a very few of the HKVCA's many activities in this report. In fact, we have a number of members and committees that have been very active over the course of the year and their work is deservedly highlighted later on in this annual report. Likewise, members of our Board of Directors have given significantly of both their time and energy to make the Association an invaluable asset to its membership. I would like to convey our most sincere gratitude to our Board of Directors.

I would be remiss were I to fail to acknowledge the work of the HKVCA's small but dedicated staff, led by Joanne Yuen, our Secretary General. Joanne and the HKVCA team have done a terrific job in the past year and we could not have achieved what we have without their commitment.

自2009年开始,本会每年组织一期私募投资基础课程。 该综合性课程设有一系列不同单元,旨在帮助专业人士 更深入的理解创业及私募投资行业的核心原则。我们亦 与多年的老伙伴,香港交易及结算所(港交所)、香港大学 和香港科技大学的MBA学院等继续保持紧密合作。去年 的课程吸引了138人参与,是自开设以来的最高记录。

当然,我们的会员们也中意轻松享乐。本着这一精神, 我们在过去的一年里也开展了许多备受欢迎的社交活动。领衔的便是我们的年度庆祝晚宴。宴会于2015年1 月20日的亚洲私募投资论坛召开前夜举行,近200位宾 客前来赴宴,共享音乐、表演与美食。2015年4月24日 举办的年度高尔夫球日以及一年两次的系列品酒会皆一 如既往受到欢迎和追捧。

行业发展

本协会一如既往地重视推动专业发展和促进行业认知。 为此,作为本协会的全新举措之一,我们的研究委员会 分别于2014年12月和2015年6月发布了第一、第二期协 会期刊。我们亦发表了一份特别联合报告以审视香港私 募投资状况。研究成果是宝贵的资源。我们与商业、学 术、贸易及其他公共机构合作开展新举措。这些举措不 仅总体上有益于创业及私募投资行业,还为协会带来了 巨大福利。

我很荣幸地告诉大家,香港《2015年税务(修订)(第2号) 条例》已于2015年7月17日刊宪并于同日生效。该条例 把适用于离岸基金的利得税豁免延伸至私募基金。感谢 技术委员会及对外关系委员会为此付出的巨大努力。现 在此豁免已成为法律,我们盼望越来越多的基金管理者 可以来香港设立公司、拓展业务,以巩固香港作为环球 金融中心的地位。

在香港乃至全球范围内,我们的行业面临了日益增加的 监管。本协会一项最重要且最优先的使命,便是通过政 府机构与行业互动、监管、征税的方式,来预测并促进 行业发展。

董事局,委员会和秘书处团队
